

MES Environmental Limited is committed to the protection of the environment and the prevention of pollution. This shall be appropriate to the purpose, size and context of the organisation and to the specific nature of its environmental risks and opportunities. This applies to not only the immediate vicinity of our sites, but also the wider environment, including other locations and sensitive receptors who may be affected by our activities.

We will establish, implement, and maintain an integrated management system to include environmental processes that shall enable us to manage risks and opportunities presented by our activities and facilities and the way in which they are used and operated. This will comprise of policies and processes aligned with ISO 14001:2015 – environmental management system standards.

Commitment will be given to fulfil legal and compliance obligations, as well as other requirements, and to continually improve our performance by:

- Actively complying with all legal requirements, permit conditions, and other relevant standards and requirements
- Assessing the ways in which our operations and activities affect the environment, and instigating measures to control these effectively
- Setting annual objectives and targets designed to further reduce environmental impact, and drive continual improvement of the Environmental Management System and enhance environmental performance. These shall be periodically reviewed by senior management
- Ensuring that all equipment that is required to control and monitor pollution is in good working order and well maintained, and in compliance with BAT (Best Available Techniques)
- Monitor and report all key operating parameters, and determine trends and patterns which can indicate where improvement is necessary
- Promote the submission of 'positive interventions' in order for everyone to highlight a finding which has the potential to cause an environment incident, or pollution event before this occurs
- Report and investigate all accidents and incidents to an appropriate level without delay
- Commitment with regards to training, awareness, evaluation, and development of competency
- Give suitable consultation where appropriate in order to assist in decision making
- Ensuring necessary resources are available, including seeking appropriate competent advice where required
- Reviewing performance with regards to the environmental performance through inspections and audits (including environmental Duty of Care)
- Directing and supporting workers and other interested parties to contribute to the effectiveness of the Environmental Management System
- Adherence to the quality and health and safety aspects of the integrated management system

Leadership and commitment, including awareness, active support, and feedback, is expected by all managers as we recognise that this is critical for the success of the management system and the achievement of its intended outcomes. This is particularly relevant for top management who shall ensure that continual improvement is driven from the top.


We expect all our employees and interested parties to share this commitment by complying with our policies, and where required our processes, and to understand that they too have legal and moral obligations to themselves and to others with regard to the protection of the environment.

The Environmental Manager is responsible for ensuring the provision of advice on environmental matters to support this policy however, everyone is responsible for following it as well as leaders expected to lead it.

This policy shall be communicated to all employees working for and on behalf of the company and is made available to all interested parties.
